BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section 384.24, subsection 3, Code 1981, is amended by adding the following new lettered paragraph:

NEW LETTERED PARAGRAPH. The acquisition, construction, reconstruction, improvement, repair, and equipping of waterworks, water mains, and extensions, and real and personal property, useful for providing potable water to residents of a city.
