10 EXPLANATION

11 This bill provides that a meeting of a school board to  
12 discuss strategy in negotiating with employees of the dis-  
13 trict who are not covered by a collective bargaining agree-  
14 ment is not subject to the requirements of the chapter on  
15 open meetings.

16 The bill takes effect July 1 following its enactment.
