1 Section 1. Section 633.82, Code 1981, is amended to read  
2 as follows:

3 633.82 DESIGNATION OF ATTORNEY. The designation of the  
4 attorney ~~or-attorneys~~ employed by the fiduciary to assist  
5 him in the administration of the estate shall be filed in  
6 ~~said~~ the estate proceedings. ~~Such~~ The designation shall state  
7 the attorney's name and, post-office address, and telephone  
8 number. The designation shall clearly state the name of the  
9 attorney who is in charge of the case and the attorney's name  
10 shall not be listed by firm name only.

11 EXPLANATION

12 This bill provides that the designation of an attorney  
13 employed to assist a fiduciary in the administration of an  
14 estate shall include the attorney's name, address, telephone  
15 number, and if more than one attorney is employed, the name  
16 of the attorney in charge of the case. The name of the law  
17 firm of which the attorney is a member is not sufficient in  
18 the designation.

19 This bill takes effect July 1 following its enactment.
