13 EXPLANATION

14 This bill prohibits the sale of licenses or tags for
15 commercial fishing gear, certificates for commercial fishing
16 gear operators, licenses for bait dealers, and licenses for
17 fishing, hunting, mussel taking, and trapping to residents
18 of states who do not sell similar licenses, tags, or
19 certificates to residents of Iowa. At present, this
20 restriction only applies to the sale of licenses or tags for
21 commercial fishing gear, certificates for commercial fishing
22 operators, and licenses for bait dealers.

23 The bill takes effect July 1 following its enactment.

RELATING TO THE RECIPROCITY OF CERTAIN FISH AND GAME LICENSES FOR NONRESIDENTS.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section 109.112, Code 1981, is amended to read as follows:
