1 Section 1. Section 428.28, unnumbered paragraph 2, Code
2 1983, is amended to read as follows:

3 Every individual, copartnership, corporation, or association
4 ~~or-city~~ which operates a public utility on a nonprofit basis,

6 the first day of May of each calendar year, make a report
7 on blanks to be provided by the department of revenue of all

14 EXPLANATION

15 This bill removes the requirement that a city utility must
16 annually report all of the property owned by it within a city
17 to the department of revenue.

AN ACT
RELATING TO THE REPORTING OF PROPERTY OWNED BY A CITY UTILITY.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section 428.28, unnumbered paragraph 2, Code 1983, is amended to read as follows:

Every individual, copartnership, corporation, or association ~~or city~~ which operates a public utility on a nonprofit basis, as defined in section 428.24 shall annually, on or before the first day of May of each calendar year, make a report on blanks to be provided by the department of revenue of all of the property owned by ~~such~~ the individual, copartnership, corporation, or association ~~or city~~ within the incorporated limits of any city in the state, and give ~~such~~ other information as the director of revenue shall ~~require~~ require.
