19 EXPLANATION

20 Section 1 of this bill provides an additional month for
21 counties to complete their applications for community mental
22 health and mental retardation funds.

23 Section 2 correspondingly adds thirty days for review and
24 approval of the applications by the department of human
25 services.

26 This bill takes effect July 1 following its enactment.

EXTENDING THE DATES FOR APPLICATION AND APPROVAL OF COMMUNITY MENTAL HEALTH AND MENTAL RETARDATION FUNDING.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section 225C.10, subsection 1, paragraph b, Code 1983, is amended to read as follows:

b. Submits or joins other counties in submitting, prior to ~~September~~ October 15 of each year, an application for a share of the general allocation for the succeeding fiscal year which is in conformity with subsection 2.

Sec. 2. Section 225C.10, subsection 3, Code 1983, is amended to read as follows:

3. Each application shall be for a period of at least one year and shall be acted upon as soon as reasonably possible by the director, who shall notify the applicant county or counties of the action on the application no later than ~~November~~ December 1 of the year in which the application is submitted.
