1 Section 1. Chapter 28E, Code 1983, is amended by adding  
2 the following new section:

3 NEW SECTION. 28E.18 SHARED USE OF FACILITIES. Before  
4 proceeding to construct or purchase a facility as otherwise  
5 provided by law, a public agency shall inquire of other public  
6 agencies having facilities within the same general geographic  
7 area concerning the availability of all or part of those fa-  
8 cilities for rent or sharing by agreement with the inquiring  
9 public agency. If there are no suitable facilities available  
10 for rent or sharing, the governing body of the public agency  
11 shall record its findings in its meeting minutes.

12 EXPLANATION

13 This bill provides that, before proceeding to construct  
14 or purchase a facility, a public agency shall inquire of other  
15 public agencies having facilities in the same general  
16 geographic area whether the facilities are available for rent  
17 or sharing. If there are no suitable public facilities  
18 available, the governing body of the public agency shall  
19 record its findings in its meeting minutes.

20 This bill takes effect July 1 following its enactment.

AN ACT

RELATING TO THE SHARED USE OF FACILITIES BY PUBLIC AGENCIES.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Chapter 28E, Code 1983, is amended by adding the following new section:

NEW SECTION. 28E.18 SHARED USE OF FACILITIES. Before proceeding to construct or purchase a facility as otherwise provided by law, a public agency shall inquire of other public agencies having facilities within the same general geographic area concerning the availability of all or part of those facilities for rent or sharing by agreement with the inquiring public agency. If there are no suitable facilities available
