1 WHEREAS, section 340.2, unnumbered paragraph 2, Code 1981,

22 tion to certain county officers and deputies as authorized
23 by the 1981 Code during the 1981-1982 fiscal year are
24 validated, legalized and confirmed.

25 EXPLANATION

26 This bill legalizes the payment of additional compensation
27 to certain county officers and deputies. Payment was approved
28 as authorized by statute for the 1981-1982 fiscal year and
29 intervening legislative action repealed the statutory
30 authorization for the payment. The bill takes effect July
31 1 following its enactment.
