1 Section 1. Section 2.15, Code 1983, is amended by adding
2 the following new unnumbered paragraph:

3 NEW UNNUMBERED PARAGRAPH. A standing committee may call

13 EXPLANATION

14 This bill authorizes a standing committee of the general
15 assembly to call upon a state agency or political subdivision
16 for any assistance or information which shall be provided
17 to the extent it is within the resources or authority of the
18 agency or subdivision.

19 This bill takes effect July 1 following its enactment.

RELATING TO THE AUTHORITY OF A STANDING COMMITTEE OF THE
GENERAL ASSEMBLY TO CALL UPON A STATE AGENCY OR POLITICAL

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section 2.15, Code 1983, is amended by adding
the following new unnumbered paragraph:

NEW UNNUMBERED PARAGRAPH. A standing committee may call
upon any department, agency or office in the state, or any
political subdivision of the state, for such information and
assistance as may be needed in the performance of its duties
and the information and assistance shall be furnished to the
