1 Section 1. Section 14.13, Code 1983, is amended by adding
2 the following new subsection as subsection 3 and renumbering
3 the remaining subsections:

4 NEW SUBSECTION. 3. Correct internal references to sec-
5 tions which are cited erroneously or have been repealed, and
6 names of agencies, officers, or other entities which have
7 been changed, when there appears to be no doubt as to the
8 proper methods of making the corrections. The Code editor
9 shall compile a list of the corrections made under this sub-
10 section in Code editor's notes to the edition of the Code
11 in which the corrections are made. This list shall be
12 available to the public.

13 EXPLANATION

14 This bill authorizes the Code editor to correct
15 misreferences or references to repealed sections or changed
16 names, when the proper method of correction is obvious and
17 a note is available to explain that a correction has been

AN ACT

PERMITTING THE CODE EDITOR TO EDITORIALY CORRECT INTERNAL REFERENCES TO SECTIONS WHICH ARE CITED ERRONEOUSLY OR HAVE BEEN REPEALED, AND NAMES OF AGENCIES, OFFICERS, OR OTHER ENTITIES WHICH HAVE BEEN CHANGED.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section 14.12, Code 1983, is amended by adding the following new subsection as subsection 3 and renumbering the remaining subsections:

NEW SUBSECTION. 3. Correct internal references to sections which are cited erroneously or have been repealed, and names of agencies, officers, or other entities which have been changed, when there appears to be no doubt as to the proper methods of making the corrections. The Code editor shall compile a list of the corrections made under this subsection in Code editor's notes to the edition of the Code
