1 Section 1. Section 280A.35, unnumbered paragraph 1, Code
2 1983, is amended to read as follows:

3 A merged area may not purchase land which will increase

10 to January 1, 1969.

11 EXPLANATION

12 This bill permits a merged area to purchase additional
13 property which would cause the merged area to exceed the 320
14 acre limitation if the state board of public instruction
15 approves.

16 The bill takes effect July 1 following its enactment.

RELATING TO THE AMOUNT OF LAND OWNED BY A MERGED AREA.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section 280A.35, unnumbered paragraph 1, Code 1983, is amended to read as follows:

A merged area may not purchase land which will increase the aggregate of land owned by ~~such~~ the merged area, excluding land ~~which has been or may be~~ acquired by donation or gift, by to more than three hundred twenty acres without the approval of the state board. ~~Such~~ The limitation ~~shall~~ does not apply to a merged areas area owning more than three hundred twenty
