1 Section 1. The following amendment to the Constitution
2 of the State of Iowa is proposed:

3 Section 7, subdivision 2 entitled "School Funds and School
4 Lands", of Article IX of the Constitution of the State of
5 Iowa is repealed.

6 Sec. 2. The foregoing proposed amendment, having been
7 adopted and agreed to by the Sixty-ninth General Assembly,
8 thereafter duly published, and now adopted and agreed to by
9 the Seventieth General Assembly, in this Joint Resolution,
10 shall be submitted to the people of the state of Iowa at the
11 general election in November of the year nineteen hundred
12 eighty-four (1984) in the manner required by the Constitution
13 of the State of Iowa and the laws of the state of Iowa.

14 EXPLANATION

15 This Joint Resolution repeals the section of the Iowa
16 Constitution that requires that the money subject to the
17 support and maintenance of common schools be distributed to
18 the districts based upon the number of youths between the
19 ages of five and twenty-one years of age.

A JOINT RESOLUTION

PROPOSING AN AMENDMENT TO THE CONSTITUTION OF THE STATE OF IOWA RELATING TO THE DISTRIBUTION OF MONEY SUBJECT TO THE SUPPORT AND MAINTENANCE OF COMMON SCHOOLS.

BE IT RESOLVED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. The following amendment to the Constitution of the State of Iowa is proposed:

Section 7, subdivision 2 entitled "School Funds and School Lands", of Article IX of the Constitution of the State of Iowa is repealed.

Sec. 2. The foregoing proposed amendment, having been adopted and agreed to by the Sixty-ninth General Assembly, thereafter duly published, and now adopted and agreed to by the Seventieth General Assembly, in this Joint Resolution, shall be submitted to the people of the state of Iowa at the
