House File 2070 provides that the clerk of district court shall charge a \$3 fee for filing and entering an agricultural supply dealer's lien or any statutory lien for which a specific fee has not been enumerated in section 602.8105 of the Code.

There is currently no Code section which specifies the fee to be charged for filing these liens with the clerk of court.

FISCAL EFFECT: There were 249 agricultural supply dealer's liens filed with the Secretary of State's office during the first six months of FY 86, but this level is expected to decline. It is not known how many statutory liens for which a specific fee has not been enumerated were filed. This bill is not expected to have a significant fiscal effect.
