AN ACT

RELATING TO THE NUMBER OF STATE OFFICERS OR EMPLOYEES REQUIRED TO REQUEST PAYROLL DEDUCTION FOR PURPOSES OF PURCHASING INSURANCE.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section 79.17, subsection 1, unnumbered paragraph 1, Code 1985, is amended to read as follows:

For the purposes of purchasing insurance and at the request of five-hundred two hundred fifty or more state officers or employees, the state officer in charge of the payroll system shall deduct from the wages or salaries of the state officers or employees an amount specified by each of the officers or
