HOUSE FILE 2401

In compliance with a written request received April 2, 1986, a fiscal note for HOUSE FILE 2401 AS AMENDED AND PASSED BY THE HOUSE is hereby submitted pursuant to Joint Rule 17. Data used in developing this fiscal note are available from the Legislative Fiscal Bureau to members of the Legislature upon request.

House File 2401 as amended and passed by the House creates an Iowa management training revolving fund to receive tuition fees from state agencies which send employees to Iowa management training system courses. The moneys are to be used to pay the actual and necessary expenses incurred by the Iowa Merit Employment Department in administering the Iowa Management Training System. The unobligated or unencumbered balance in this fund at the end of the fiscal year shall not revert to the General Fund.

FISCAL EFFECT: This bill codifies an existing practice of the Iowa Merit Employment Department. The Iowa Management Training System and revolving fund has been in existence since 1980. Therefore, there is no fiscal effect.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. NEW SECTION. 19A.12 IOWA MANAGEMENT TRAINING SYSTEM AND REVOLVING FUND.
