4 WHEREAS, the city of Bloomfield, Iowa has incurred a deficit
5 in the general fund of the city in the amount of three hundred
6 seventy-two thousand four hundred ninety dollars and ninety-eight
7 cents; and

8 WHEREAS, the city council of the city desires to transfer two
9 hundred forty-four thousand nine hundred eighty-five dollars and
10 nineteen cents from its trust and agency fund and thirty-four
11 thousand nine hundred sixty-two dollars and eighty-six cents from
12 its insurance fund to reduce the amount of the deficit; and

13 WHEREAS, doubts have arisen concerning the legality of the
14 transfers proposed from the trust and agency fund and the
15 insurance fund to the general fund of the city and it is deemed
16 advisable and necessary to put such doubts and all others that
17 may be raised concerning the transfer to rest; NOW THEREFORE,
18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

1 Section 1. That the transfer of two hundred seventy-nine
2 thousand nine hundred forty-eight dollars and five cents from
3 the trust and agency fund and the insurance fund to the

AN ACT

WHEREAS, the city of Bloomfield, Iowa has incurred a deficit in the general fund of the city in the amount of three hundred seventy-two thousand four hundred ninety dollars and ninety-eight cents; and

WHEREAS, the city council of the city desires to transfer two hundred forty-four thousand nine hundred eighty-five dollars and nineteen cents from its trust and agency fund and thirty-four thousand nine hundred sixty-two dollars and eighty-six cents from its insurance fund to reduce the amount of the deficit; and

WHEREAS, doubts have arisen concerning the legality of the transfers proposed from the trust and agency fund and the insurance fund to the general fund of the city and it is deemed advisable and necessary to put such doubts and all others that may be raised concerning the transfer to rest; NOW THEREFORE,

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. That the transfer of two hundred seventy-nine thousand nine hundred forty-eight dollars and five cents from the trust and agency fund and the insurance fund to the
