12 EXPLANATION

15 chapter 326 by personal or corporate check. If a check does
16 not clear, a penalty of five percent of the applicable fees is
17 assessed against the registrant.

REQUIRING THE STATE DEPARTMENT OF TRANSPORTATION TO ACCEPT
PAYMENT BY CHECK OF PROPORTIONAL REGISTRATION FEES.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. NEW SECTION. 326.10A PAYMENT BY CHECK.

The department shall accept payment of fees under this chapter by personal or corporate check. The fee shall be deemed to have been paid upon receipt of the check. However the department shall not issue plates, stickers or other identification of vehicles subject to proportional registration until sufficient time has elapsed to ensure that
