EXPLANATION

1 This bill requires that one of the nembers of the state 2 board of regents be a student or recent graduate of one of the 3 three institutions of higher education under the control of 4 the state board of regents. Qualifications are specified and 5 the student representative has a two-year term rather than a 6 six-year term.
