1 Section 1. Section 441.3, Code 1987, is amended to read as
2 follows:

3 441.3 EXAMINING BOARD.

4 At a regular meeting of the conference board each voting
5 unit of the conference board shall appoint one qualified
6 person who is a resident of the assessor jurisdiction to serve
7 as a member of an examining board to hold an examination for
8 the positions of assessor or deputy assessor. This examining
9 board shall organize as soon as possible after its appointment
10 with a chairperson and secretary. All its necessary
11 expenditures shall be paid as hereinafter provided. Members
12 of the board shall serve without compensation. The terms of
13 each shall be for six years.

14 Sec. 2. Section 441.31, unnumbered paragraph 1, Code 1987,
15 is amended to read as follows:

16 The chairperson of the conference board shall call a
17 meeting by written notice to all of the members thereof of the
18 board for the purpose of appointing a board of review for all
19 assessments made by the assessor. ~~Such~~ The board of review
20 may consist of either three members or five members. As
21 nearly as possible this board shall include one licensed real
22 estate broker and one registered architect or person
23 experienced in the building and construction field. In the
24 case of a county, at least one member of the board shall be a
25 farmer. Not more than two members of the board of review
26 shall be of the same profession or occupation and ~~no two~~
27 ~~members of the board of review shall be citizens-of-the-same~~
28 ~~city-or-township-except-in-the-case-of-cities-having-their-own~~
29 ~~assessor-in-which-case-the-members-shall-be-selected-so-as-to~~
30 ~~give-each-of-the-townships-included-within-the-city-the~~
31 ~~highest-possible-numerical-representation~~ residents of the
32 assessor jurisdiction. The terms of the members of the board
33 of review shall be for six years, beginning with January 1 of
34 the year following their selection. In boards of review
35 having three members the term of one member of the first board

1 to be appointed shall be for two years, one member for four
2 years and one member for six years. In the case of boards of
3 review having five members, the term of one member of the
4 first board to be appointed shall be for one year, one member
5 for two years, one member for three years, one member for four
6 years and one member for six years.

EXPLANATION

8 The bill provides that members appointed to examining
9 boards and boards of review shall be residents of the assessor
10 jurisdiction served by the examining board or board of review.
