15 BACKGROUND STATEMENT

16 SUBMITTED BY THE AGENCY

17 Many class "E" liquor control licensees have requested that
18 the alcoholic beverages division maintain their records of
19 purchases from the division as confidential information. The
20 division believes that this request is reasonable and
21 desirable to prevent one class "E" liquor licensee from
22 acquiring a business advantage over another licensee by com-
23 piling sales data from the division. Additionally, any sales
24 information on an individual class "E" licensee should be
25 revealed by the licensee. This bill will not restrict the
26 reporting of cumulative sales data on all licensees or sales
27 data by territory.

AN ACT

PROVIDING THAT THE RECORDS OF THE PURCHASE OF ALCOHOLIC LIQUOR FROM THE ALCOHOLIC BEVERAGES DIVISION BY INDIVIDUAL CLASS "E" LIQUOR CONTROL LICENSEES ARE CONFIDENTIAL AND PROVIDING AN EFFECTIVE DATE.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section 22.7, Code Supplement 1987, is amended by adding the following new subsection:
NEW SUBSECTION. 25. Records of purchases of alcoholic liquor from the alcoholic beverages division of the department of commerce which would reveal purchases made by an individual class "E" liquor control licensee. However, the records may be revealed for law enforcement purposes or for the collection of payments due the division pursuant to section 123.24.
