2 EXPLANATION

3 This bill strikes a requirement that the department of
4 corrections biennially prepare a report for submission to the
5 governor and the general assembly relating to the management
6 of the community-based corrections programs and services.

7 BACKGROUND STATEMENT

8 SUBMITTED BY THE AGENCY

9 The above is a proposed department of corrections bill
10 amending the community-based corrections section of the Code.
11 Section 905.11 requires the submission of a biennial plan for
12 community-based corrections. This requirement is redundant,
13 requiring a duplication of the planning and reporting
14 requirements already called for from the department as a whole
15 under sections 246.108 and 246.115. Additionally, the
16 inclusion of community-based corrections in the annual state
17 budgeting process fulfills the planning and reporting intent
18 of this section. This change is recommended by the
19 legislative fiscal bureau.
