7 EXPLANATION

8 This bill provides for the exclusion of a child care center

12 in order to eliminate duplication of licensure.

8 This bill provides for the exclusion of a child care center
9 for sick children, licensed by the Iowa department of public
10 health and operated as a part of a pediatrics unit in a
11 hospital, from the definition of "child day care", in order to
12 eliminate duplication of licensure.

13 BACKGROUND STATEMENT

14 SUBMITTED BY THE AGENCY

15 By adding an exemption for sick child care centers operated
16 as part of a pediatrics unit, it will prevent duplication of
17 licensing since those facilities are already licensed by the
18 department of health. It would also prevent confusion over
19 requirements that need to be met under two separate licensing
20 agencies. The department of human services would continue to
21 license sick child care centers operated outside of a licensed
22 pediatrics unit of a hospital. The state day care advisory
23 committee will be working on new rules for sick child care
24 centers this coming year.

RELATING TO CHILD DAY CARE FOR SICK CHILDREN.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section 237A.1, subsection 7, Code Supplement 1987, is amended by adding the following new paragraph:

NEW PARAGRAPH. d. A child care center for sick children operated as part of a pediatrics unit in a hospital licensed by the department of inspections and appeals pursuant to chapter 135B.
