7 EXPLANATION

8 This bill authorizes a tax levy not exceeding twenty-seven
9 cents per thousand dollars of assessed value for the support
10 of a public library. The levy can be initiated by a petition
11 of eligible electors equal to at least ten percent of the
12 persons voting at the preceding regular city election and a
13 majority vote in favor of the levy at the next regular city
14 election. The levy may be discontinued by the same
15 procedures.

AN ACT

AUTHORIZING A TAX LEVY FOR CITY LIBRARIES BY PETITION AND REFERENDUM.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section 384.12, Code 1987, is amended by adding the following new subsection:

NEW SUBSECTION. 20. A tax not to exceed twenty-seven cents per thousand dollars of assessed value for support of a public library, subject to petition and referendum
