FISCAL NOTE

REQUESTED BY REPRESENTATIVE SHERZAN

In compliance with a written request received March 5, 1987, a fiscal note for House Joint Resolution 14 is hereby submitted pursuant to Joint Rule 17. Data used in developing this fiscal note are available from the Legislative Fiscal Bureau to members of the Legislature upon request.

House Joint Resolution 14 nullifies an administrative rule of the Department of Employment Services which provides that a lockout is a labor dispute.

Fiscal Effect: The department of employment services cannot project a meaningful estimate of the impact on the trust fund. Further, the department cannot determine the nature of future rulings of the Employment Appeal Board and the courts or how those rulings will impact the number of labor disputes that could be labeled "lockouts" or the number of employees likely to be involved. Therefore, it is not possible to provide a sound estimate of the potential impact on the unemployment compensation trust fund.
