AN ACT

RELATING TO THE RESIDENCY OF AN AGENT FOR AN AUTHORIZED COMPANY ENGAGED IN THE BUSINESS OF BECOMING SURETY UPON BONDS IN CRIMINAL CASES.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section 682.11, Code 1987, is amended to read as follows:

682.11 ~~CERTIFICATE-OF-AUTHORITY~~ AUTHORITY TO ACT AS SURETY
-- AGENT QUALIFICATIONS.

1. Any company engaged in the business of becoming surety upon bonds shall file, with the clerk of the district court of any county in which ~~it shall~~ the company will do business, a certificate from the commissioner of insurance that it the company has complied with the law and is authorized to do business in this state.

2. An agent for a company authorized to engage in the business of becoming surety upon bonds pursuant to subsection 1 must be a resident of this state for the purpose of acting
