10 NEW SUBSECTION. 2. A residential care facility licensed
11 under chapter 135C which is approved for the care of children.

12 EXPLANATION

13 This bill adds an exemption to the definition of child
14 foster care so that child foster care does not include care
15 furnished in a licensed hospital or in a licensed intermediate
16 care facility or skilled nursing facility. The bill also
17 exempts a licensed residential care facility from licensure as
18 a foster care facility.

AN ACT
RELATING TO THE DEFINITION OF FOSTER CARE.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section 237.1, subsection 3, Code 1987, is amended by adding the following new lettered paragraph:

NEW LETTERED PARAGRAPH. e. Care furnished in a hospital licensed under chapter 135B or care furnished in an intermediate care facility or a skilled nursing facility licensed under chapter 135C.

Sec. 2. Section 237.4, Code 1987, is amended by adding the following new subsection after subsection 1 and renumbering the remaining subsections:
