RELATING TO THE ELECTION OF THE PRESIDENT OF THE STATE BOARD
OF EDUCATION.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section 256.7, Code 1989, is amended by adding the following new subsection:

NEW SUBSECTION. 13. Elect to a two-year term, from its members in each even-numbered year, a president of the state board, who shall serve until a successor is elected and qualified.
