Section 1. Section 455A.4, Code 1989, is amended by adding the following new subsection:

NEW SUBSECTION. 5. The department may accept payment of any fees, interest, penalties, subscriptions, or other payments due or collected by the department, or any portion of such payments, by credit card. The department may adjust the amount of the payment to reflect the costs of processing the payment as determined by the treasurer of state and the
