10 EXPLANATION

11 The bill allows a city council member to hold the office of
12 chief of the volunteer fire department concurrently with the
13 office of city council member if the fire department serves a
14 population of not more than 2,000, and if no other candidate
15 who is not a city council member is available to hold the
