BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section 303.92, subsection J, Code 1989, is amended by adding the following new paragraph:

NEW PARAGRAPH. d. May accept gifts, contributions, bequests, endowments, or other moneys, including but not limited to the Westgate endowment fund, for any or all purposes of the department under this subchapter. Interest earned on moneys accepted under this paragraph shall be credited to the fund or funds to which the gifts, contributions, bequests, endowments, or other moneys have been deposited, and is available for any or all purposes of the department under this subchapter. The department shall report annually to the general assembly regarding the gifts,
