## Ĩ SUBMITTED BY THE AGENCY Currently the Environmental Protection Commission has com-3 plete commission authority to approve the entire budget of the 4 Department that will be submitted to the Governor and General 5 Assembly, while the Natural Resource Commission has no 6 authority in this area. The proposed changes to the Code 7 would give each commission the authority to approve the budget 8 that is submitted to the Governor and General Assembly for the 9 programs under each commission's respective jurisdiction.

## AN ACT

RELATING TO THE DUTIES OF THE NATURAL RESOURCE COMMISSION AND THE ENVIRONMENTAL PROTECTION COMMISSION WITH RESPECT TO BUDGET APPROVAL REQUIREMENTS.
