1 Section 1. Section 109.95, unnumbered paragraph 1, Code  
2 1989, is amended to read as follows:

34183 A license shall be required of each such fur dealer and  
4 each employee, agent, or representative of a fur dealer except  
5 when the employee, agent, or representative is operating  
6 solely on the premises of a licensed fur dealer. A fur dealer  
7 shall conduct business only at the location specified on the  
8 dealer's license, at an established fur auction, at the  
9 nonadvertised residence of a licensed fur harvester, or at the  
10 place of business specified on the license of any resident fur  
11 dealer. The commission shall, upon application and the  
12 payment of the required license fee, furnish proper  
13 certificates to dealers.

14 EXPLANATION

15 This bill provides that each employee, agent, or  
16 representative of a fur dealer must also be licensed as a fur  
17 dealer unless that person operates solely on the premises of a  
18 licensed fur dealer. The bill also provides that a fur dealer  
19 can transact business only at the location specified on the  
20 dealer's license, at an established fur auction, at the  
21 nonadvertised residence of a licensed fur harvester, or at the  
22 place of business specified on the license of any resident fur  
23 dealer.

24 A violator is guilty of a simple misdemeanor.

Section 1. Section 109.95, unnumbered paragraph 1, Code 1989, is amended to read as follows:

A license shall be required of each such fur dealer and each employee, agent, or representative of a fur dealer except when the employee, agent, or representative is operating solely on the premises of a licensed fur dealer. A fur dealer shall conduct business only at the location specified on the dealer's license, at an established fur auction, at the nonadvertised residence of a licensed fur harvester, or at the place of business specified on the license of any fur dealer. A licensed fur dealer may purchase location permits to operate at locations other than at the location specified on the fur dealer's license. Each location permit shall be valid only for the one location specified on the location permit and shall entitle the fur dealer and employee, agent, or representative of the licensed fur dealer to operate at that location. The commission shall, upon application and the payment of the required license fee, furnish the proper certificates license and location permits to dealers the dealer.
