1 Section 1. NEW SECTION. 642.24 GARNISHMENTS -- SUPPORT
2 PAYMENT PRIORITY.

3 The court shall include in any order for garnishment a
4 requirement that any amount garnisheed for the payment of a
5 support obligation, whether or not the amount represents a
6 current or delinquent support obligation, shall first be paid
7 out of the garnisheed funds, after subtracting applicable
5006 8 fees, before any amounts garnisheed for other purposes are
9 paid out of the garnisheed funds.

10 EXPLANATION

11 This bill requires a court to provide in any garnishment
12 order that any support obligation of the debtor shall first be
13 paid out of any funds garnisheed, after subtracting any
14 applicable fees, prior to those funds being disbursed for any
15 other purpose.

AN ACT

RELATING TO THE PAYMENT OF A SUPPORT OBLIGATION OUT OF GARNISHEED FUNDS.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. NEW SECTION. 642.24 GARNISHMENTS -- SUPPORT PAYMENT PRIORITY.

The court shall include in any order for garnishment a requirement that any amount garnisheed for the payment of a support obligation, whether or not the amount represents a current or delinquent support obligation, shall first be paid out of the garnisheed funds, after subtracting applicable fees related to the issuance of the specific garnishment, before
