1 Section 1. NEW SECTION. 109.40 DEER HUNTING LICENSES --
2 WEAPONS.

3 Subject to the availability of licenses pursuant to section
4 109.38, a resident is entitled to a separate license to hunt
5 deer during the same hunting season with each of the following
6 weapons: a shotgun, bow and arrow, and black powder muzzle
7 loading rifle or musket.

8 A shotgun, bow and arrow, and black powder muzzle loading
9 rifle or musket may be used for the taking of deer.

10 Sec. 2. Section 110.1, subsection 2, paragraph c, Code
11 1989, is amended to read as follows:

12 c. Wild turkey hunting license for residents \$ ~~20.00~~
13 10.00

14 EXPLANATION

15 This bill authorizes a resident to receive a separate
16 license to hunt deer with a shotgun, bow and arrow, and black
17 powder muzzle loading rifle or musket during the hunting
18 season.

19 The bill also reduces the license fee for a resident wild
20 turkey license from twenty dollars to ten dollars.
