A fiscal note for HOUSE FILE 709 is hereby submitted pursuant to Joint Rule 17. Data used in developing this fiscal note is available from the Legislative Fiscal Bureau to members of the Legislature upon request.

House File 709 permits the Treasurer to enter into an agreement with a financial institution to provide credit card receipt processing for state departments that are authorized to accept payment by credit card. The state departments are permitted to adjust their fees to cover the expense of the credit card transaction processing.

Fiscal Impact: There will be no cost to the state. The credit-card user will pay the cost through an adjustment to the fee which will cover the increased costs. The increase to the fee when using a credit card is expected to be between 1% and 3%.
