1 Section 1. Section 7E.5, subsection 1, paragraph t, Code
2 1989, is amended to read as follows:

3 t. The department of human rights, created in section
4 601K.1, which has primary responsibility for services relating
5 to Spanish-speaking people, children, youth, and families,
6 women, persons with disabilities, community action agencies,
7 criminal and juvenile justice planning, the status of blacks,
8 and deaf persons.

9 Sec. 2. Section 9A.11, subsection 1, Code 1989, is amended
10 to read as follows:

11 1. The attorney general may institute a legal proceeding
12 against an athlete agent on behalf of the state, and shall
13 institute legal proceedings at the request of the secretary of
14 state, to enforce this chapter.

15 Sec. 3. Section 10A.202, subsection 1, Code 1989, is
