AN ACT

RELATING TO THE SALE OR CONTRACTING FOR GOODS AND SERVICES
BETWEEN A CIVIL SERVICE COMMISSIONER AND A CITY.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section 400.2, unnumbered paragraph 2, Code 1989, is amended to read as follows:

Civil service commissioners shall not buy-from, sell to, or in any manner become parties, directly, to any contract to furnish supplies, material, or labor to the city in which they are commissioners except as provided in section 362.5. A
