

EXPLANATION 9 This bill provides that an information or indictment for 10 11 sexual abuse committed on or with a child under the age of 12 twelve (currently ten) years of age must be found before the 13 victim's twenty-fifth birthday. AN ACT

RELATING TO THE TIME PERIOD WITHIN WHICH AN INFORMATION OR IN-DICTMENT FOR SEXUAL ABUSE WITH A CHILD UNDER THE AGE OF TWELVE SHALL BE FOUND.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section 802.2, Code 1989, is amended to read as follows:

802.2 SEXUAL ABUSE OF CHILD.

An information or indictment for sexual abuse in the first, second or third degree committed on or with a child under the age of ten twelve years shall be found within-four-years after DONALD D. AVENSON Speaker of the House
