20 BACKGROUND STATEMENT

21 SUBMITTED BY THE AGENCY

22 Section 89B.8(3) references federal OSHA standards on which
23 IOSH bases its regulations. When new federal standards are
24 adopted, the Iowa statute must be changed for each new
25 standard issued. This language will allow the Department of
26 Employment Services, Division of Labor Services, to promulgate
27 and enforce rules based on the most recent federal standards.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section 89B.8, subsection 3, Code 1989, is amended by striking the subsection and inserting in lieu thereof the following:

3. The commissioner shall adopt rules based upon the occupational safety and health standards which have been adopted as permanent standards by the United States secretary of labor in accordance with federal law. If the hazardous communication regulation, 29 C.F.R. § 1910.1200, is amended or repealed, the commissioner shall review the amendment or repeal and take action with respect to the state standards, including the amendment or repeal of the state standards,
