1 Section 1. Section 321.1, subsection 17, Code 1991, is  
2 amended to read as follows:

3 17. "Special mobile equipment" means every vehicle not  
4 designed or used primarily for the transportation of persons  
5 or property and incidentally operated or moved over the  
6 highways, but not including road construction or maintenance  
7 machinery and ditch-digging apparatus. This description does  
8 not exclude other vehicles which are within the general terms  
9 of this subsection. ~~However, this section does not include~~

11 ~~semitrailer.~~

12 Sec. 2. Section 321.118, Code 1991, is repealed.

13 EXPLANATION

14 This bill repeals a section requiring registration for  
15 funds on which a portable mill or corn sheller is mounted and  
16 requires that they be included in the category of special  
17 mobile equipment.
