10 This bill shifts the responsibility for the adoption of  
11 rules, which relate to the obtaining of agency consent for an

15 responsibility for the adoption of rules relating to the  
16 obtaining of agency consent for officials to engage in the  
17 same activities remains with the individual agencies.
