1 Section 1. 441 Iowa administrative code, rule 78.1,  
2 subrule 20, paragraph a, subparagraph (4), unnumbered  
3 paragraph 1, is nullified.

4 Sec. 2. EFFECTIVE DATE. This joint resolution, being  
5 deemed of immediate importance, takes effect upon enactment.

6 EXPLANATION

7 This joint resolution nullifies an administrative rule of  
8 the department of human services which limits payment for  
9 liver transplants under the medical assistance program. The  
10 limitation in the rule under notice would provide payment only  
11 for liver transplants for persons under 18 years of age under  
12 certain specified medical circumstances. The effective date  
13 of the rule has been delayed until the adjournment of the  
14 Seventy-fourth General Assembly, 1991 Session, by action of  
15 the administrative rules review committee. The joint  
16 resolution takes effect upon enactment.
