2 unnumbered paragraphs 1 and 2, which constitute the amending  
3 clause and the Code section number and headnote, if enacted by

12 SEC. 39. Section 56.10A, Code 1991, is repealed effective  
13 July 1, 1992, and section 68B.5, Code 1991, is repealed  
14 effective December 31, 1992.

15 Sec. 3. This Act takes effect July 1, 1992.

16 EXPLANATION

17 This bill changes the effective date of the repeal of  
18 current gift law provisions from July 1, 1992, to December 31,  
19 1992. The new gift law takes effect January 1, 1993. This  
20 bill takes effect July 1, 1992.
