SUBMITTED BY THE AGENCY

14 The national council of architectural registration boards
15 holds their region meetings in April and their annual meeting
16 in June. Frequently, since the terms of the board members
17 expire on April 30, it could be possible to have a board
18 member functioning as an officer who would not be able to
19 fulfill the entire length of the term. All other professions
20 within the professional licensing division elect their
21 officers during the months of either March or April.
