1 Section 1. Section 260C.15, subsection 4, Code 1993, is
2 amended to read as follows:

3 4. The votes cast in the election shall be canvassed and
4 abstracts of the votes cast shall be certified as required by
5 section 277.20. In each county whose commissioner of
6 elections is responsible under section 47.2 for conducting
7 elections held for a merged area, the county board of
8 supervisors shall convene ~~at-ten-o'clock-a.m.~~ on the last
9 Monday in September or at the last regular board meeting in
10 September, canvass the abstracts of votes cast and declare the
11 results of the voting. The commissioner shall at once issue
12 certificates of election to each person declared elected, and
13 shall certify to the merged area board in substantially the
14 manner prescribed by section 50.27 the result of the voting on
15 any public question submitted to the voters of the merged
16 area. Members elected to the board of directors of a merged
17 area shall qualify by taking the oath of office prescribed in
18 section 277.28.

19 EXPLANATION

20 This bill allows a county board of supervisors to canvass
21 the votes cast in a regular merged area annual election either
22 on the last Monday in September or at the last regular board
23 meeting in September. Currently, the board of supervisors
24 must convene to canvass these votes at 10 a.m. on the last
25 Monday in September.

AN ACT
RELATING TO MERGED AREA ANNUAL ELECTIONS.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section 260C.15, subsection 4, Code 1993, is amended to read as follows:

4. The votes cast in the election shall be canvassed and abstracts of the votes cast shall be certified as required by section 277.20. In each county whose commissioner of elections is responsible under section 47.2 for conducting elections held for a merged area, the county board of supervisors shall convene ~~at ten o'clock a.m.~~ on the last Monday in September or at the last regular board meeting in September, canvass the abstracts of votes cast and declare the results of the voting. The commissioner shall at once issue certificates of election to each person declared elected, and shall certify to the merged area board in substantially the manner prescribed by section 50.27 the result of the voting on any public question submitted to the voters of the merged area.
