27 This bill eliminates a requirement that the owner of a
28 multipurpose vehicle with permanently installed disabled
29 equipment must not have income which exceeds 150 percent of
30 the poverty level in order to qualify for the special lower
31 registration fees available for disabled-equipped vehicles.

**HOUSE FILE 409
FISCAL NOTE**

A fiscal note for House File 409 as amended by S-3428 is hereby submitted pursuant to Joint Rule 17. Data used in developing this fiscal note is available from the Legislative Fiscal Bureau to members of the Legislature upon request.

House File 409 as amended by S-3428, reduces the registration fee on multipurpose vehicles for persons who have been issued a handicapped parking device from a fee based on weight and value to a flat fee of \$75.00 for vehicles that are 1 to 5 model years old and \$55.00 for each subsequent year. This bill also requires that handicapped parking signs include a sign stating the amount of the fine for improperly using a handicapped parking space.

Assumptions

1. There are an estimated 15,000 persons with handicapped devices or handicapped plates who own multipurpose vehicles. These persons generate approximately \$1,965,000 in revenue to the Road Use Tax Fund.
2. Under this legislation, 60% (9,000) of the persons with handicapped devices or handicapped plates will pay a \$75.00 registration fee and 40% (6,000) of the persons will pay a \$55.00 fee. This will generate \$1,005,000 to the Road Use Tax Fund.

Fiscal Effect

House File 409, as amended by S-3428, will reduce the amount of revenue deposited in the Road Use Tax Fund by \$960,000 annually.



BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section 321.109, subsection 1, unnumbered paragraph 2, Code 1993, is amended to read as follows:

The annual registration fee for a multipurpose vehicle with permanently installed equipment manufactured for and necessary to assist a handicapped disabled person who is either the owner or a member of the owner's household in entry and exit of the vehicle or for a multipurpose vehicle if the vehicle's owner or a member of the vehicle owner's household uses a wheelchair as the only means of mobility shall be seventy-five sixty dollars for the first through fifth model years and shall be fifty-five dollars for each model year thereafter. To qualify under this paragraph, the owner's income and earnings must not exceed one hundred fifty percent of the federal poverty level as published by the United States department of health and human services. For purposes of this unnumbered paragraph, "uses a wheelchair" does not include use of a wheelchair due to a temporary injury or medical condition.

Sec. 2. Section 321.124, subsection 3, paragraph h, subparagraph (6), Code 1993, is amended to read as follows:

(6) The annual registration fee for a multipurpose vehicle with permanently installed equipment manufactured for and necessary to assist a handicapped disabled person who is either the owner or a member of the owner's household in entry and exit of the vehicle or for a multipurpose vehicle if the vehicle's owner or a member of the vehicle owner's household uses a wheelchair as the only means of mobility shall be
