ALLOWING THE USE OF MOBILE TRANSMITTERS TO HUNT COYOTES AND SUBJECTING VIOLATORS TO AN EXISTING SCHEDULED FINE.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section 481A.24, Code 1993, is arended to read as follows:

481A.24 USE OF MOBILE TRANSMITTER PROHIBITED.

A person who is hunting shall not use a mobile radio transmitter to communicate the location or direction of game or fur-bearing animals or to co-ordinate coordinate the movement of other hunters. This section does not apply to the hunting of coyotes from-danuary-1-through-March-31 except LEONARD L. BOSWELL President of the Senate
