EXPLANATION

This bill changes three references in the Code relating to the recording of instruments in the office of county recorder. Section 1 of this Act provides for the recording of the first page of a soil and water conservation district plan rather than filing the page. Section 2 relates to the recording of a waiver so that vehicular traffic laws and rules do not apply to certain real estate. Section 3 provides that an affidavit of a surviving spouse for the change of title to real estate shall be recorded in the office of county recorder rather than filed in the office of county auditor.
