- 1 Section 1. Section 306.23, Code 1995, is amended to read 2 as follows:
- 3 306.23 NOTICE -- PREFERENCE OF SALE.
- 4 For the sale of unused right-of-way notice of intention to
- 5 sell the tract, parcel, or piece of land, or part thereof,
- 6 must be sent, not less than ten days prior to the sale, by
- 7 certified mail, by the agency in control of the land, to the
- 8 last known address of the present owner of adjacent land from
- 9 which the tract, parcel, piece of land, or part thereof, was
- 10 originally bought or condemned for highway purposes, and if
- 11 located in a city, to the mayor. The If the tract, parcel, or
- 12 piece of land was acquired by purchase and not through
- 13 condemnation, the notice shall give an opportunity to the
- 14 present owner of adjacent property to be heard and make offers
- 15 for the tract, parcel, or piece of land to be sold, and if the
- 16 offer is equal to or exceeds in amount any other offer
- 17 received, it shall be given preference by the agency in
- 18 control of the land. If the tract, parcel, or piece of land
- 19 was acquired through condemnation, the notice shall also
- 20 provide that the present owner of adjacent property from which
- 21 the tract, parcel, or piece of land was condemned may purchase
- 22 the tract, parcel, or piece of land, prior to the sale, for an
- 23 amount equal to the damages awarded through condemnation for
- 24 the tract, parcel, or piece of land. Neglect or failure for
- 25 any reason, to comply with the notice, does not prevent the
- 26 giving of a clear title to the purchaser of the tract, parcel,
- 27 or piece of land.
- 28 EXPLANATION
- 29 This bill provides that when land acquired for highway
- 30 purposes through condemnation is not needed for that purpose
- 31 and will be sold, the present owner of adjacent property shall
- 32 be notified and allowed to purchase the property for an amount
- 33 equal to the damages awarded for the condemnation of the
- 34 property.
