- Section 1. Section 153.15, Code 1995, is amended to read 2 as follows:

 153.15 DENTAL HYGIENISTS -- SCOPE OF TERM -- SUPERVISION
- 4 BY DENTIST.
 5 A licensed dental hygienist may perform those services
 6 which are educational, therapeutic, and preventive in nature
- 7 which attain or maintain optimal oral health as determined by
- 8 the board of dentistry and may include but are not necessarily
- 9 limited to complete oral prophylaxis, application of
- 10 preventive agents to oral structures, exposure and processing
- 11 of radiographs, administration of medicaments prescribed by a
- 12 licensed dentist, obtaining and preparing nonsurgical,
- 13 clinical and oral diagnostic tests for interpretation by the
- 14 dentist, preparation of preliminary written records of oral
- 15 conditions for interpretation by the dentist. A licensed
- 16 dental hygienist shall perform all services authorized in this
- 17 section under the general supervision of a dentist currently
- 18 licensed and actively practicing in Iowa. General supervision
- 19 means that a dentist has authorized the services that the
- 20 dental hygienist provides. The supervising dentist need not
- 21 be present in the facility while the dental hygienist performs
- 22 the services. Each supervising dentist shall determine the
- 23 extent of the authorization and the duration of the
- 24 authorization according to the individual needs of the patient
- 25 and the dentist's professional judgment. Such These services
- 26 shall be performed under-supervision-of-a-licensed-dentist-and
- 27 in a dental office, a public or private school, public health
- 28 agencies, hospitals, and the armed forces, but nothing herein
- 29 shall-be-construed-to-authorize in this section authorizes a
- 30 dental hygienist to practice dentistry.
- 31 EXPLANATION
- This bill defines the general supervision of a licensed dentist over a licensed dental hygienist.
